



Major Tax Legislation Signed Into Law

On July 4th, the president signed sweeping tax & spending legislation into law. There is too much in the bill to enumerate here, but some of the key provisions are:

- Permanent lower tax rates and higher standard deductions, which were previously set to expire after 2025
- Tip and overtime income (up to \$25,000) exempt for many workers from 2025 through 2028
- 100% bonus depreciation is back and made permanent for qualifying business assets
- The Child Tax Credit has been increased to \$2,200 per child, indexed for inflation
- Taxpayers age 65+ will receive an extra \$6,000 deduction, phased out at higher incomes, 2025–2028
- The state and local tax deduction cap has been raised to \$40,000 subject to income limits
- The 1099-K reporting threshold has been permanently raised to \$20,000 and 200 transactions, reversing the previous \$600 threshold that was set to take effect, and the threshold for filing forms 1099-MISC and NEC have been raised to \$2,000 beginning in 2026
